**TEMPORARY PROHIBITION OF THROUGH TRAFFIC & PARKING
& SUSPENSION OF LOADING BAY**

DEVON COUNTY COUNCIL hereby give **NOTICE** that:

for a maximum of 21 days

No person shall cause or permit any vehicle to proceed on the sections of Affected Roads.

Roads affected -

**BROAD STREET AND SILVER STREET FROM OUTSIDE ROBERTS AT NO. 13 TO OUTSIDE LLOYDS BANK.
BROOK STREET FROM ITS JUNCTION WITH SILVER STREET FOR APPROXIMATELY 15M.**

The alternative, signed, route for vehicles will be via - B3177 THROUGH ALFINGTON - C834 (OLD A30) PAST NAGS HEAD FARM - HAYNE LANE - DEVONSHIRE ROAD - HEATHPARK WAY - A375 EXETER ROAD - A375 SIDMOUTH ROAD TO HARE AND HOUNDS PUTTS CORNER - CHINEWAY ROAD - YONDER STREET AND JESU STREET.

No person shall cause or permit any vehicle to wait on the sections of Affected Roads.

Roads affected –

**BROOK STREET FOR 15M IN FRONT OF THE GARDEN OF COBBLERS COTTAGE - FOR 26M BETWEEN THE GARDEN AT THE REAR OF 51 SANDHILL STREET AND THE REAR GARDEN OF 1 BROOKLANDS ORCHARD.
CHAPEL LANE FOR 17M IN FRONT OF MOUNT HERMON.
YONDER STREET OUTSIDE NO.S 6, 8 AND 10**

No person shall cause or permit any vehicle to wait or load and unload on the sections of Affected Roads.
