Town Council Comments:

Ottery St Mary Town Council, after much discussion three members voted in support of this application and three members voted against it and there was one abstention. The Chairman of the Planning Committee was not prepared to give a casting vote one way or another.

However, the Town Council then voted unanimously for an amendment to the effect that it was not content with the way the Development was carried out in the first place and wanted the original application to be complied with. It hopes that there will be sufficient tree planting taking place, the roofs are to be replaced with a porous surface and that every effort is made to minimise the run off problem.
