Section 3 – External Auditor Report and Certificate 2017/18

1 Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2018; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2017/18

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- The smaller authority has not addressed the 'except for' matters raised by the external auditor when qualifying the prior year annual return. The figures in Section 2, Boxes 2 and 3 in the prior year column should have been restated, as reported in the prior year External Auditor Report. The figures in Section 2, Boxes 2 and 3 for the prior year should read £161,016 and £151,568 respectively.
- In the completion of the Annual Internal Audit Report, the internal auditor has drawn attention to a breach of the Standing Orders and Financial Regulations. The internal auditor has concluded that there was no suggestion of financial impropriety and this was an isolated incident which has since been resolved. However, in light of this information the smaller authority should have answered "No" to Assertion 3 on Section 1.
